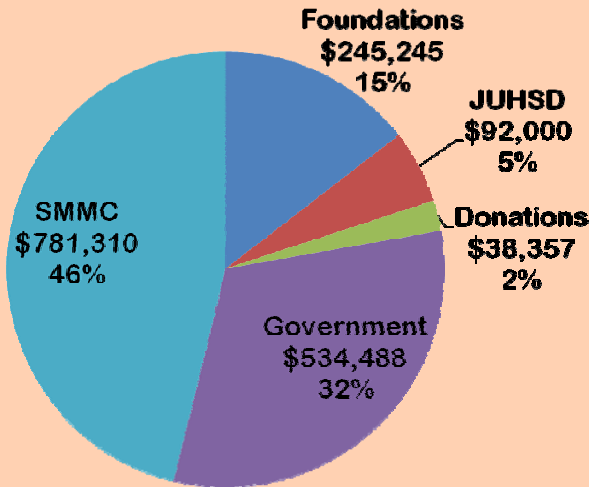

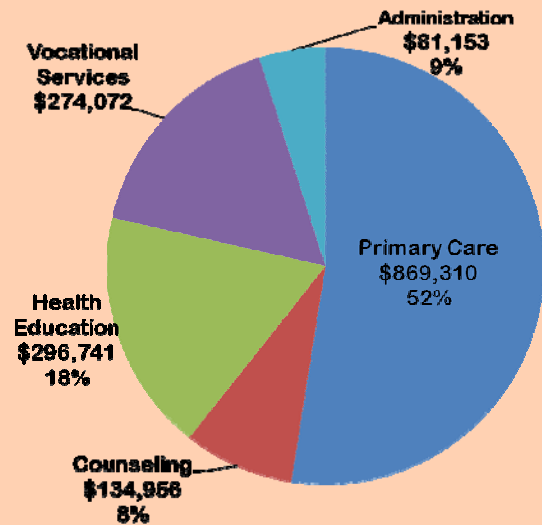
Revenues and Expenses July 2010 - June 2011

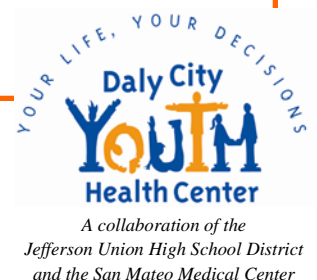
