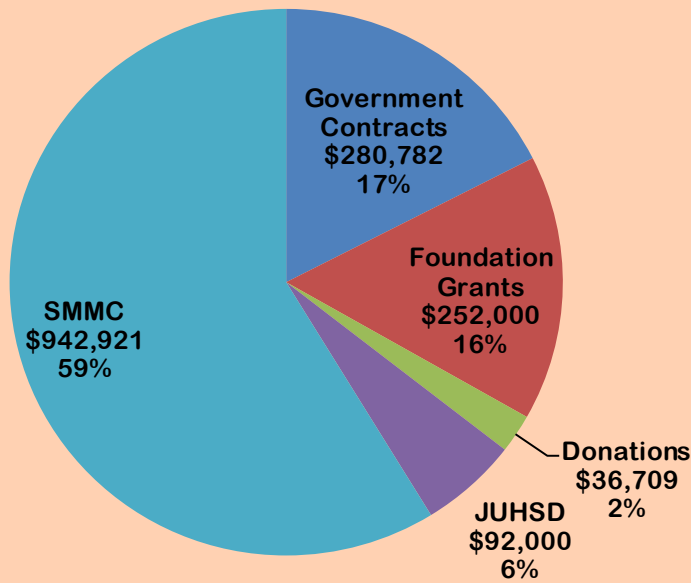

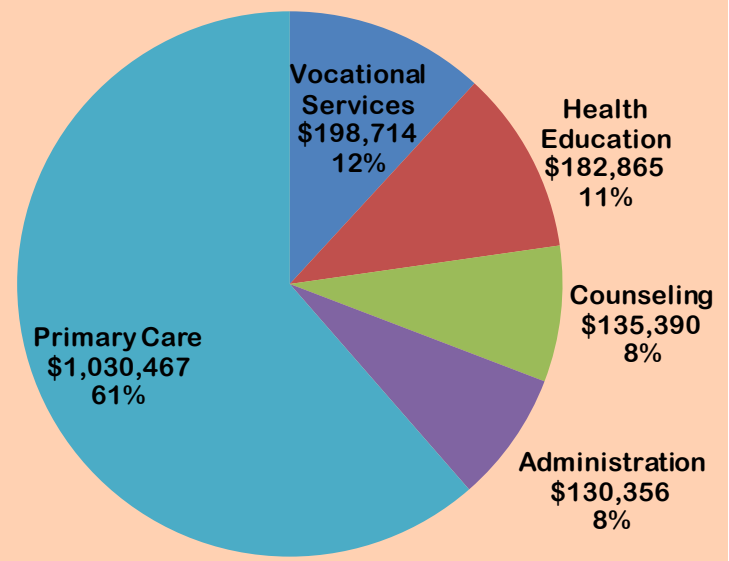
Revenues and Expenses July 2011 - June 2012

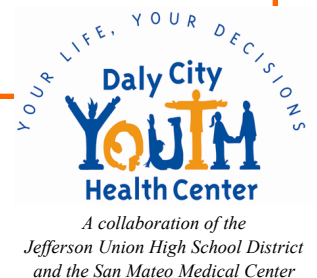
